supervisory role, the Associate Vice President personally manages a major gift portfolio of approximately 50-75 major gift prospects and is responsible for generating gift revenue in accordance with annual goals.

In conjunction with the Vice President, sets annual, measurable performance fundraising goals for the Foundation and for each member of the team and schedules regular meetings to ensure development officer performance is tracking to goal. Provides strategic consultation across the team in refining donor strategy, developing relevant gift proposals and building stewardship plans in service to optimizing gift revenue from each development officer's portfolio. Provides direction to the Director of Prospect Research to ensure that major gift portfolios grow and mature with the goal of increasing major gift revenue. Provides strategic leadership to the Director of Annual Giving, coordinating with Major Gifts to optimize the symbiotic relationship between the two activities. Provides direction to the Scholarship Administrator to optimize the impact of the Foundation's scholarship program. Provides annual performance reviews to the members of their

Strategy

As a valued member of the St. Cloud State University Foundation leadership team, the Associate Vice President of University Advancement partners with the Vice President on matters of strategic planning, Board engagement, campaign administration and institutional engagement. The Associate Vice President of University Advancement participates as a member of the Gift Acceptance Committee and consults with and develops policies in partnership with the Vice President.

Planned Giving

The Associate Vice President of University Advancement administers the SCSU Foundation's planned giving communications; fields and assigns inquiries to Development Officers.

Problem Solving

The Associate Vice President of University Advancement routinely solves issues pertaining to donor issues concerning gift administration, fund financial reports, etc.

Direct Reports

The Associate Vice President will supervise three Directors of Development; one Director of Annual Giving; one Director of Prospect Research; one Scholarship Administrator.

Budget

The Associate Vice President of University Advancement works in conjunction with the Vice President of University Advancement and the SCSU Foundation's Director of Finance to plan and develop the annual Foundation budget - \$1.3M in non-University funds. That budget is presented annually to the SCSU Foundation Board of Directors who have a fiduciary responsibility for the Foundation's finances. The Associate Vice President of University Advancement has direct oversight in administering \$337,000 in Foundation program expenses annually that support major, planned and annual gifts, and prospect research.
